Although your recently purchased used truck was acquired from a quality dealer who inspected it thoroughly prior to the sale, a catastrophic major component failure could occur in the near future. There is no assurance that a used truck with hundreds of thousand of miles of service logged won't breakdown while you are the owner. Premium 2000 Plus™ can provide you with "Major Medical" for your truck so that you can continue to meet your financial commitments.

The Premium 2000 Plus™ Limited Warranty Program covers all parts requiring lubrication that come in contact with manufacturer's approved fluids. The Schedule of Covered Internal Components are as follows:

ENGINE: Internally lubricated hard parts limited to pistons, piston rings, wrist pins, connecting rods, connecting rod bearings, crankshaft, main bearings, camshaft and cam bearings, cam followers, rocker arms shafts, pushrods, hydraulic lifters, intake and exhaust valves, valve springs, valve guides, oil pump and pick up screen, timing chain and gears, timing chain tensioner(s). The engine block, cylinder head(s), timing case cover, oil pan, valve covers and intake manifold are covered only if damaged by the failure of a covered component. Damage resulting from failures by related components but not limited to: Seals and Gaskets, radiators, coolers and cooler lines, water pump, thermostat, motor mounts, fuel pump, fuel injection pump and nozzles or electronic control devices are not covered.

DIFFERENTIAL: Internally lubricated hard parts including carrier case, gear sets, bearings, bushings, axle shafts, limited slip clutchpack, axle shafts. Required Seals and Gaskets to complete repairs. The differential housing is covered only if damaged by a covered component. Damage resulting from the failures of related components but not limited to: Seals and Gaskets, electronic controls, shift levers, linkage, radiators, mounts, external oil coolers and lines are not covered.

TRANSMISSION: Internally lubricated hard parts of the Manual or Automatic transmission including shaft(s), gear sets, shift forks, synchronizers, blockers, bearings, bushings, oil pump, valve body, torque converter, governor, bands, drums, gear sets, bearings, bushings. The transmission case is covered only if damaged by a covered component. Required Seals and Gaskets to complete covered repairs. Damage resulting from the failures of related components but not limited to: Seals and Gaskets, electronic controls, shift levers, linkage, radiators, mounts, external oil coolers and lines, manual transmission clutch-disc, pressure plate, throwout bearing, pilot bearing, hydraulic clutch master and slave cylinder(s) are not covered.

Taxes & Fluids: State and local taxes where applicable and fluids that are required to complete covered repairs.

The Components Listed Above are the Only Parts that are Protected by this Warranty.

* Turbochargers, fuel injectors and engine (jake) brakes are not covered components.

Customer Maintenance Responsibilities

You are required to maintain your truck as specified in the Premium 2000 Plus™ Limited Warranty Agreement. Service intervals, as outlined, must be followed for covered and all related components. Services must be performed by a qualified, licensed service facility. Receipts for all work completed will be requested in case of a filed claim.

The Premium 2000 Plus™ Claims Department can be reached by telephone 24 hours a day, 365 days a year. The claims adjusters are fair, experienced and helpful. Lets face it, if your truck is suffering a major component failure you are not having your best day. We are mindful that our responsibility is to get your truck back on the road and operating properly with a minimum of downtime.
